# **Millage Revenue Capture Agreement**

The acting clerk read the agreement between the Saginaw County Road Commission and the City of Zilwaukee. The agreement states that on August 6<sup>th</sup>, 2024, Saginaw County will vote on a millage for the purpose of funding to repair, re-build and restore existing county roads within the townships, and streets within the cities and villages of Saginaw County. If approved by the electorate of Saginaw County, the Road Millage will increase the limitation of the total amount of general ad-valorem taxes which may be imposed for all purposes upon all taxable real personal property in Saginaw County, as authorized by Const 1963, art 9, 6 and levy up to 2.0 Mill (\$2.00 per \$1,000) of taxable valuation on such property as finally equalized during the years 2024-2029, both inclusive.

## Millage Revenue Capture Agreement Continued-

If the millage passes the city will receive roughly \$96,000.00 to use towards repairing local streets. Money is not to be used for County roads. If the residents of Zilwaukee turn down the millage, and other places vote the millage through, we will still receive the money. # Moving forward with Duclos Electric to update the electric panel at the Fire Station and install a Generac generator for a total of \$10,808.39.

The Fire Department is working on some kitchen improvements and the electrical needs to be updated. This is the perfect time to put in the generator. Two quotes were received, Nelson Electric came in at \$16,600.00 and Duclos came in at \$10,808.39. Once the paperwork is filled out the generator will have a 10-year warranty. \$15,000.00 is budgeted for building repair and replacement and \$20.00 has been spent so far. Motion passed.
