The meeting was called to order at 6:00 p.m. by Mayor Eugene Jolin

The invocation and pledge were offered by the clerk.

PUBLIC HEARING – FLOOD PLAIN MANAGEMENT ORDINANCE AMENDMENT

Special Guests – Lions members Tom Jarzabkowski and Dale Balko

Mr. Jarzabkowski addressed the council with a request to approve the installation of a new fishing pier on the north end of the riverfront park. This required by Consumers Energy, the property owner, before Consumers would consider the project. A motion was made by Luplow and seconded by M/Jolin to approve the request. The motion passed. Mr. Jarzabkowski then made another request for approval to add three fishing piers at the south end of the boat ramp in the future. Council comments: The mayor reported that there is an opening on the Planning Commission and one on the Parks and Recreation Board.

Administrator comments:

The administrator informed the council that the Parks and Recreation 5 year plan needs to be updated. She also mentioned that the permit from EGLE for the paving of the parking lot at the Community Hall has not been received yet.

Budget Amendments

Policing Contract with Kochville

The administrator informed the council of meetings between officials of the City of Zilwaukee and Kochville Township concerning partnering of our police department and Kochville Township that are not part of Kochville's DDA. The proposed contract was drawn up by the township attorney and reviewed by the city's attorney with some recommended changes. The fee for our police department would be \$16,000.00 per year with payments in \$4,000.00 quarterly. A motion was made by Luplow and seconded by Bohnsack to approve the contract. The motion passed. Voting aye: Bohnsack, Luplow and M/Jolin. Voting nay: Comstock

Fireworks Donation

The administrator asked for a \$500.00 from the Community Promotion budget to help with the fireworks display to be put on July 8th. The event is put on each year by Prince, owner of Nikki's and donations from patrons of his store. A motion was made by Comstock and seconded by Bohnsack to approve the request. The motion passed. Voting aye: Bohnsack, Comstock, Luplow and M/Jolin. Voting nay: none.
