ARPA Allocation Resolution

The clerk read a resolution to allocate the ARPA funds of \$160,680.00 in the following manner: \$82,840.00 for the water main and up to \$77,840.00 for pump station replacement. Trash Collection Increase.

The administrator reported that trash collection fee has been increased from \$189.04 a year to \$196.20 per year. She asked for approval of the increase.
